# American Legion moves to open up membership

Membership eligibility in The American Legion is determined by Congress through the establishment of specific dates of declared hostilities in which U.S. military personnel were activated. Since its founding in 1919, membership in The American Legion has been open to veterans of World War I, World War II, Korean War, Vietnam War, Lebanon/Grenada, Panama and Gulf War/War on Terrorism.

There are at least 12 known combat operations that required an activated military personnel, such as the Cold War, Libyan Conflict and Persian Gulf Conflicts, and resulted in about 1,600 U.S. military men and women casualties. However, because these operations are unrecognized by the U.S. government as a period of war, those who served during these timeframes are not eligible for membership in The American Legion.

The American Legion's National Executive Committee passed a resolution during its annual Fall Meetings in Indianapolis Oct. 17 to change that.

Resolution No. 1, "Unrecognized armed hostilities recognition," calls on Congress to declare that the United States has been continuously engaged in a state of war from December 7, 1941 to present, and for Congress to direct the Department of Veterans Affairs to qualify a wartime veteran as any military service personnel who served honorably under Title 10 for at least one day from December 7, 1941 to present.

Following the passing of Resolution No. 1, the NEC adopted Resolution No. 2, "Unrecognized armed hostilities membership date change," which will change membership dates for The American Legion. This resolution will only be put in motion once the actions of Resolution No. 1 are approved by Congress. Once approved, membership in The American Legion will be open to the following war periods: April 6, 1917 to Nov. 11, 1918, and Dec. 7, 1941 to the date of cessation of armed hostilities as determined by the U.S. government.

The American Legion believes that membership in the organization should be extended to all U.S. military personnel who served on active duty during the hostile events that are not seen as a period of war.

## Notes from the Department Service Officer

\*\*\*Excerpts Taken From "The Maine Legionnaire" \*\*\*

One of the bills I have been tracking for you is H.R. 299. This bill would have granted blue water Navy the ability to claim presumptive conditions of Agent Orange exposure. This Bill did not pass through the Senate. In January after that happened a veteran won a case in the US Court of Appeals of the Federal Circuit. As you may know this level of court does set precedence. This is very good news, but remember that the VA has the option to appeal this ruling. It could be tied up in court action for a while.

The Appeals Modernization Act goes into effect this month, but we still have many traditional appeals still pending. I can tell you that the appeals process has slowed down here at the Togus Regional Office because of the RAMP program. The VA has Identified 4 regional offices that handle only RAMP appeal. This has influenced this regional office because the traditional appeals from those offices have come here. This affects not only traditional appeals but remands as well.

The office has been working on creating an effective outreach program. We started last fall at the Fryeburg Fair in collaboration with the ALR chapter now out of the Bridgeton Post. We learned a lot from that event. The office now can upload a claim to the VA straight from the computer. We will soon be able to digitally sign documents and we are working with the IT folks to get access to the websites we use every day while we are out of the office. What this will enable us to do is go to a remote site out of the office and be able to do the exact same thing we do at the office.

#### **RAMP**

Rapid Appeals Modernization Program continues to be fine-tuned. As an update there are only a few Regional Offices that conduct the RAMP reviews. Togus is not one of them. So, all RAMP reviews leave the state. The denial rate for this program is still very high, around 75% for both lanes now.

#### VA Comp and Pen examinations!

The Comp and Pen location is now on the third floor next door to my office. They also have a full time psychologist on staff now. This in the long run will be good for our veterans. If a veteran complains to you about a compensation and pension exam, let me know. It could affect the rating for the veteran. I have a fix for that but I need to know what is going on.

#### State of Maine Veterans

The VA provided this following information.

Total number of veterans 116,782 Total number of veteran over 65 57,792

Based on these numbers 49.49% of all veterans in Maine are over 65 years old.

Total number receiving disability Compensation

26,862

Based on these numbers less than 5% of all veterans in Maine are receiving disability compensation.
